- 1. Apologies for absence: These were received from Cllr J Walford and Cllr Henry-Ames
- To elect a Chairman of the council for the council year 2022/23: Cllr V Patel was elected as Chairman. Proposed by Cllr M Crowe, seconded by Cllr C Ingham. All councillors were in favour.
- To elect a Vice-Chairman of the council for the council year 2022/23: Cllr B Gallagher was
  elected as Vice-Chairman. Proposed by Cllr V Patel, seconded by Cllr M Crowe. All councillors
  were in favour.
- To elect a Chairman of the planning committee for the council year 2022/23: Cllr C. Homes was elected Chairman of the planning committee. Proposed by Cllr C Ingham seconded by Cllr V Patel. All councillors in favour.
- To appoint a Vice-Chairman of the planning committee for the year 2022/23: Position remains

- 6. Resolution that standing orders be suspended: No members of the public present.
- 7. To receive and approve the minutes of the Parish meeting held on the 13<sup>th</sup> July 2022, extraordinary meetings held on the 3<sup>rd</sup> August, 31<sup>st</sup> August and the 7<sup>th</sup> September 2022: These were received, approved and signed by the chairman as a correct record.
- 8. Declarations of Interest: None.
- Approval by Chairman of Items for Any Other Business: (i) Statter Fields (ii) Lease on the Lodge, Westwood Park.
- 10. Chairman's Report: This had been previously circulated to and received by councillors.
- 11. Clerk's Report: This had been previously circulated to and received by councillors.
- 12. Reports, as appropriate, from members of outside bodies and working parties: Clir Holmes reported that a LCCA meeting took place which he was unable to attend. Clerk to circulate the minutes when received from Clir Holmes. Clir Silverstone informed the council that Sustainable Little Chalfont had launched a website.
- 13. Financial matters: (i)List of payments 20 September 2022 to be approved: this was reviewed, approved and signed by the Chairman.

- 16. Retrospective planning application (PL/22/1971/FA) for the erection of two mobile free range egg production units and two feed silos on Graciefields Farm, Latimer Road, Chenies: After a discussion it was decided to submit an objection to this planning application. Cllr

- Holmes will circulate the objection to all councillors and the clerk will send to Buckinghamshire planning.
- 17. Any other business: (i) Statters Field Cllr.Ingham reported that on 13 September he and Cllr Holmes had attended the Public Local Inquiry to consider confirmation of the Order for a Public Footpath around Statters Field, Planning Inspectorate Reference ROW/3276730. The parish council's position on this matter was neutral. The two councillors had observed the proceedings but did not speak. A decision by the planning inspector was to be expected in October. (ii) The Lodge, Westwood Park. Cllr Ingham reported that the draft lease renewal document, circulated with his email of 20 September, had been approved by the legal advisers of both LCPC and ATC. Both councils were planning to confirm their agreement in principle to the text at separate meetings on 26 September. Cllr Ingham and the Parish Clerk were in discussion with ATC about procedures necessary before signature could take place.
